

Saranac CSD Device Protection Plan (Insurance)

The student laptop is the responsibility of the student to whom it is assigned. Taking care of the laptop is of tremendous importance, as these devices are expected to last 4-5 years.

Saranac CSD is providing a Device Protection Plan for students and parents as part of our 1-to-1 initiative. Enrollment in the plan is optional with the understanding that if students/parents choose not to enroll in the protection plan they assume full liability for damage or loss. Enrollment will minimize any potential repair and/or replacement costs.

Cost: The DPP enrollment fee will be **\$20 annually**. This fee is due September 30th, 2022. Plans purchased after the start of the year will not be prorated. Plans are nonrefundable and there are no insurance refunds for students who leave the District before the end of the school year. If this fee presents a financial hardship, please reach out to your child's building principal.

Effective Coverage/Expiration Dates:

- **Effective date:** Coverage begins first day of school or when the nonrefundable enrollment fee is paid, whichever is later.
- **Expiration date:** Coverage ends on the earliest of the following dates: last day of school, return of device, no longer enrolled in school, or no longer eligible to use the device. Please be sure to return the device before the expiration date to ensure that coverage is always in effect.

Coverage:

- The plan covers **one** repair of non-intentional damage per school year. This includes replacing keyboard and/or cover, cracked screen, damaged port, etc.
- Any items under warranty repair are covered.

Exclusions:

- Intentional damage is not covered under the plan and will require payment for parts at full price.
- Students and parents will be responsible for the full amount of repair/replacement for damage or loss caused by dishonest, fraudulent, intentional, and negligent or criminal acts.
- Damaged or missing device stylus and/or power adapters are not part of the DPP. Please contact the Technology Department to purchase replacements.

Stolen Devices:

- If device is stolen in school, it must be reported immediately to the main office.
- If device is stolen outside of school, the parent/guardian must file a police report in a timely manner. A copy of the report must be turned in to the main office.

Cost of Replacement Parts – If student/parent declines enrollment in DPP, student/parents are responsible for all repairs/replacement costs. These prices (see reverse) are subject to change due to current pricing.
